Approve Minutes

A motion was made by John Roxbury, Jr. and seconded by Mark Riverblood to approve the minutes of the November 18, 2014 regular monthly meeting as printed. Motion Carried.

Approve Financial Report

A motion was made by John Roxbury, Jr. and seconded by Mark Riverblood to approve the Financial Report for November 2014 as submitted. Beginning Balance of Township funds was \$424,646.14; total receipts of \$7,661.90; total disbursements of \$21,632.18; leaving a balance of \$410,675.86. Motion Carried Unanimously.

Old Business

A motion was made by John Roxbury, Jr. and seconded by Mark Riverblood to approve the 2015 Township pay schedule with the following increases; a \$2.00 hourly increase for Brian Dahlheimer and the backup snowplow drivers and the Deputy Clerk, and a \$1.00 hourly increase for Road Grader Operator/Duane Baker, Maintenance/Ken Henchen and Clerk/Treasurer, Connie Wubben. Motion Carried.

New Business

John Roxbury, Jr. motioned to approve the 2nd half of the Fire Contract in the amount of \$23,975.00. Jim Kusler seconded the motion. Motion Carried.

John Roxbury, Jr. motioned to approve KDV for the 2014 Audit. Mark Riverblood seconded the motion as long as there was not a significant increase from last year. Motion Carried.

Open Forum

There were no residents present.

Supervisor's Reports

John Roxbury, Jr. informed the board that he was no longer on the Planning Commission at the County, but is still on the Board of Adjustment. He also stated that Jim Roxbury was re-elected as the City of Princeton's Fire Chief for another two years.

Jim Kusler gave an update on the City of Princeton's Planning Commission.

Mark Riverblood reviewed some information on Residential Land Use and suggested that sometime in the near future, they schedule an open house so residents can come and talk about the issue.

Mr. Riverblood also gave an update on the 4R Board.

The Clerk did not have any business to address.

Approve Payment of the Bills

A motion was made by John Roxbury, Jr. and seconded by Jim Kusler to approve payment of the bills, Check numbers 10656-10688. Motion Carried.
