Approve Minutes

Approve Financial Report

A motion was made by John Roxbury, Jr. and seconded by Mark Riverblood to approve the Financial Report for January 2015 as submitted. Beginning Balance of Township funds was \$518,997.34; total receipts of \$13,545.05; total disbursements of \$36,162.29; leaving a balance of \$496,380.10. Motion Carried Unanimously.

The board discussed updating the Metes and Bounds form and replacing it with one like the County uses to simplify the process. Eugene Stoeckel motioned to start using the new Metes and Bounds form. John Roxbury, Jr. seconded the motion. Motion Carried.

New Business

John Roxbury, Jr. stated that he and Mr. Riverblood would be attending a meeting with the County Sherriff for an advisory group.

Clerks Business

The Clerk informed the board that it would cost \$300 to update the payroll software. John Roxbury, Jr. motioned to approve the payment. Eugene Stoeckel seconded the motion. Motion Carried.

The Clerk stated that she renewed the Life Insurance and did not make any changes and informed the Board that she gave them forms to update their beneficiary information.

The Clerk informed the Board that she would be working on the annual newsletter and asked if they wanted to add anything. The Board asked the Clerk to include some information regarding the possible rezoning of Rural Residential and also something about the road maintenance pertaining to brush cutting.

Approve Payment of the Bills

A motion was made by Eugene Stoeckel and seconded by John Roxbury, Jr. to approve payment of the bills, Check numbers 10716-10739. Motion Carried.
