(1:08) Pledge of Allegiance Recited

(1:51) Review of Applicants.

(2:18) Adam Ripple stated that it is an open meeting and any audience member can be in attendance, but applicants need to be in the other room.

(6:23) Time was slated at 15 Minutes per candidate. Thomas Duden Volunteered to keep time.

(6:23-1:02:21) Candidate Interviews

(1:02:22) Adam Ripple advised the board on voting procedure.

(1:04:32) Dave Persing moved the motion to move forward with Doug Dahl as the new Clerk/Treasurer for Princeton Township. Thomas Duden seconded the motion. Motion Approved unanimously.
