City Planning Commission Liaison- No Meeting


Township Planning Commission Liaison- Mike Bishman – There was no meeting.

Mr. Hiller moved to adjourn the meeting. Mr. Bishman seconded. Motion carried. Meeting adjourned at 8:06 p.m.


